
**Regarding representation of Smt. Suprabha Dahiya IAS (Retd.) in respect of HEWO Scheme-II, Sector-19, Faridabad.**

#### **Agenda item No.7**

**Status of HEWO sites GH-33 & 38, Sector-65, Faridabad, GH-19, Sector-46, Faridabad, GH-02 & 09 Sector-12, Sonapat of HEWO Scheme-III.**

It was decided to refloat the cancelled/surrendered flats at the cost excluding interest on construction cost @ 5.5% amongst the general public as per terms and conditions of HEWO.
