## **ORDERS**

As per instructions issued vide memo no. Misc. 138-A/7/5/2006-2TCP dated 30.06.2016 by ACSTCP Haryana, the Haryana Building Code-2017 has repealed the building rules in the HUDA (Erection of Buildings) Regulations, 1979 with all other subsequent amendments and instructions issued there under. Hence, in supersession of all orders issued earlier for constitution of committees for preparation of zoning plans, approval of building plans, grant of occupation certificate in respect of various Urban Estates of Pradhikaran in Haryana, in exercise of the powers conferred by code 1.2(XXV) of The Haryana Building Code-2017; the Haryana Shehri Vikas Pradhikaran is pleased to constitute the following committees in the Pradhikaran for the purpose specified under code 2.5 with immediate effect:-
