**Subject Revision of Pay scales in HUDA with effect from
01.01.2016.**

1. The Haryana Government vide its Notification No. 1/20/2016-5PR(FD)Chandigarh dated 28th October, 2016 have revised the pay scale of its employees followed by Haryana Civil Services (Revised Pay) Rules, 2016 and Haryana Civil Services(Assured Career Progression) Rules, 2016 notified vide its notification dated 28th October, 2016.
2. It has been decided to implement the revised pay scales to the HUDA employees as per the Government notifications as HUDA is following the Government pay scales. The copy of the above notifications along with the other relevant Government instructions/notifications issued in this regard are on Finance Department Website at link <http://www.finhry.gov.in/writereaddata/Notification%20&%20Order/Pay%20Revision%20Branch/6385.pdf>
3. You are requested to take necessary action to fix the pay in the respective pay matrix, after taking option and undertaking on the prescribed format as provided in the said notifications.
4. The arrear shall be paid in cash, preferably during the current Financial year 2016-17.
5. The Interim Relief ₹ 2000/- (Two thousand rupees only) per month paid to Group C and D employees is discontinued from 1st January, 2016 and the same paid from 01.01.2016 onwards shall be recovered from them.
6. However, it is mentioned here that the cases regarding grant of Assured Career Progression Scales will be decided at Head-quarter as the Chief Administrator, HUDA is competent authority for the same. Where-ever, ACP scales in the old scales have already been granted by competent authority their pay may be fixed at your own level in accordance with the provision in the ACP Rules.



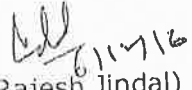
