2. Calculation of additional price of Sector-6, 7, 8 and 9 (Part), Urban Estate, Jind under Regulation 2(b) of The Haryana Urban Development (Disposal of land & Building) Regulation 1978.

1. It is submitted that land measuring 30 7.77 acres was acquired for the development of Sector-6, 7, 8 and 9 (Part), Urban Estate, Jind vide Award No. 6 dated 06.09.2005, @ ₹ 10.00 lacs per acre for 3.08 acres and ₹ 7.00 Lacs per acre for 304.69 acres and land measuring 95.25 acres was acquired vide Award o. 7 dated 06.09.2005. The Collector awarded compensation @ ₹ 6.00 lacs per acre for the land near road upto one acre depth. The awarded compensation was further enhanced by the ADJ, Jind vide order dt. 25.07.2014 and assessed the market price of the land @ ₹ 8,47,000/- and ₹ 11,02,000/- of 307.77 acres land of Award No. 6 and ₹ 6,78,000/- and ₹ 8,80,000/- for 95.25 acres land of Award No. 7. Further, Hon'ble High Court has enhanced the market price of the land @ ₹ 12.10 lacs and ₹ 16.94 lacs per acre vide order dated 30.10.2015 in RFA No. 9821 of 2014.
2. Now the policy to calculate the Additional Price has been approved by HUDA authority in its 111th meeting at Agenda No. 22 and calculations are now to be made as per this policy and Additional price is required to be fixed under Regulation 2(b) of The Haryana Urban Development (Disposal of land & Building) Regulation 1978. **For brevity, regulation 2(b) is reproduced below :-**

"ADDITIONAL PRICE" and "ADDITIONAL PREMIUM" means such sum of money as may be determined by the Chief Administrator in respect of the sale or lease of land or building by allotment, which may become payable by the transferee or lessee with respect to land or building sold or leased to him in a sector on account of the enhancement of compensation of any land or building in the same sector by the Court on a reference made under section 18 of the Land Acquisition Act, 1894, and the amount of cost incurred in respect of such reference."

Now, in view of award of Hon'ble High Court and as per Regulation 2(b) of The Haryana Urban Development (Disposal of land & Building) Regulation 1978 and as per the new policy, following calculations have been made to arrive at the additional amount which shall be payable by the Allottees/Transferees or lessees of Sector-6, 7, 8 and 9 (Part), Urban Estate, Jind:-

3. In view of above, calculations of enhancement are now to be made on the basis of land area of Sector-6, 7, 8 and 9 (Part), Urban Estate, Jind supplied by the Administrator, HUDA, Panchkula as per latest layout plan and calculations are made on the basis of actual liability as per the calculations made by the Zonal Administrator, HUDA, Hisar at the time of approval of payment of enhanced compensation to the concerned land owners. Accordingly, recovery of EC of Sector-6, 7, 8 and 9 (Part), Urban Estate, Jind has been prepared as under :-
