 Your kind attention is invited towards contents of para 5 of the Memo No.2833-STR-1-98/5075 dated 12.5.1998 which is reproduced below:

"5. Another question which has been raised is whether the registration of the first transaction between the Colonizer/ HUDA and the original allottee is to be done on the basis of the original sale price charged by the Colonizer/HUDA, or whether that is to be seen with reference to the Collector's rates.
