**Subject: Instructions-Regarding unblocking/ activation of PPM accounts in cases on account of 75% of allotment price.**

Refer to letter memo no. CITO/HSVP/2023/267431 dated 14.12.2023 on the subject cited above.

Earlier, it was decided by the competent authority to block/de- activate the PPM accounts where the allottee had defaulted in making payment of the installments of the plots towards 75% of the allotment price, as the schedule of payment lapsed long ago. Consequent to this decision, about 1042 plots have been blocked/de-activated in PPM. The decision was conveyed vide letter memo no. CITO/HSVP/2023/267431 dated 14.12.2023.

The matter has now been re-considered and it has been decided with the approval of Hon'ble Chief Minister cum Chairman, HSVP that status of all the plots, which have earlier been de-activated or blocked on account of above decision of the competent authority, due to non-payment of 75% amount within time as per the terms and conditions of the allotment letter, may be activated/ unblocked in the PPM. Estate Officers concerned will take immediate necessary steps for resumption against the allottees of such plots by invoking powers under Section 17 of the HSVP Act, 1977.

It is made clear that the above decision will not apply in respect of those cases where the plots have been blocked/ de-activated in PPM account on account of the plot having been resumed/ cancelled/surrendered and this decision will also not apply in cases where plots have been auctioned through e-auction under the e-auction policy. List of plots supplied by IT Cell, HSVP (HQ) is attached at Annexure 'A'. Further, a SOP has been prepared by the committee under the Chairmanship of Secretary, HSVP, Panchkula and same is attached as Annexure 'B'. Estate Officer concerned shall get the status of plot updated from IT Cell, HSVP after verification of facts.

Compliance of the above decision be ensured immediately and report be supplied to this office.

**Subject: Proceeding of the meeting held under the chairpersonship of Ms. Meenaxee Raj, HCS, Secretary HSVP, Panchkula for the implementation of decisions from 127th Pradhikaran weeting Regarding Plot IDs Blocked/Deactivated in PPM.**

In the 127th Pradhikaran (Authority) meeting held on 08.11.2024 under the chairpersonship of Hon'ble Chief Minister, Haryana, it was decided that plot IDs blocked or deactivated in the PPM due to non-payment of 75% of the amount would be activated/updated immediately. Notices under Section 17 of the Haryana Urban Development Authority Act, 1977, are to be issued to the eligible allottees. It was further clarified that this decision would not apply to cases where resumption orders have already been passed.

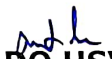
To facilitate the implementation of this decision, a meeting was convened on 19.11.2024 under the chairpersonship of Secretary, HSVP, attended by Sh. Yogesh Ranga (CITO HSVP), Sh. Navneet Sharma (ADO HSVP) , and Sh. Rakesh (System Officer). The following roadmap for implementation was decided during the meeting:

1. IDs blocked for non-payment of 75% amount shall be unblocked and proceedings under section 17 of Haryana Urban Development Authority Act, 1977, shall begin immediately. The payment link of these hitherto blocked freshly unblocked IDs shall remain suspended till issuance of notice under section 17(1)/(2)/(3)/(4), as the case may be. *Needful 10 days .*
2. All services related to the plot shall remain suspended in the respective ID until full payment is received, except payment option.
3. The IT wing of HSVP shall intimate the allottee about the progress in plot status at every stage through SMS and email notifications. IT wing shall arrange for bulk SMS adequately in advance.
4. For future cases, instead of blocking or deactivating plots in the PPM, the IT wing shall implement a provision to "hold" the plot. Only in cases where any stay on allotment acquisition etc. is given by court.
5. For plots kept on hold due to court orders, the concerned Estate Officer must upload the copy of the court order along with other

relevant details, including the next hearing date, in the utility developed by the IT wing of HSVP.

6. The IT wing shall ensure that whenever a plot is placed on hold by the competent authority, an email intimation is sent to CA HSVP, Secretary HSVP, CITO HSVP, and all other relevant stakeholders & copy of orders passed on Next Date of Hearing is uploaded. If the stay is lifted the plot will no longer be allowed to be kept in "on hold" category.
